Required Documentation	Copy of current certificate(s) indicating successful completion of a radon training course as required by § 2.10(A) of RIDOH Regulation 216-RICR-50-15-2 – Radon Control.
	Proof of passing the EPA radon contractor proficiency (RCP) exam.
	Copy of current certification as a radon mitigation specialist/supervisor with the National Radon Safety Board (NRSB) or the National Radon Proficiency Program (NRPP). Note: AARST membership is not the same as NRPP certification.
Performance Requirements	Radon supervisor services must be performed under the auspices of a licensed Radon Contractor. A Radon Supervisor must be licensed as a Radon Contractor or be employed by a licensed Radon Contractor. A Radon Supervisor may be named on more than one Radon Contractor's license. RIDOH must be notified of termination of services from any Radon Contractor listed with this application within five (5) business days of the change.

Please make a photocopy of your entire completed application for your records before mailing it to RIDOH. RIDOH is not responsible for providing you with a photocopy of your application.
