

CONSENT ORDER

Pursuant to R.I. Gen Laws §23-17.9-1 et seq. and the Rules and Regulations promulgated thereunder, 216-RICR-40-05-22, the Rhode Island Department of Health ("RIDOH") has investigated Complaint No. C23-1202 (the "Complaint") charging NAYELI SULIVERES ("Respondent", with violations of R.I. Gen Laws §23-17.9-1 et seq.

After review and consideration by RIDOH with respect to the allegations of unprofessional conduct of Respondent, the following are and shall constitute,

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. That on March 10, 2022, Respondent was issued a 120 Day Temporary Nursing Assistant Permit, license number NA 33439-T, that expired on July 10, 2022, by the Rhode Island Department of Health.
- 2. That during October and November of 2023, Respondent was employed as a nursing assistant at the Friendly Home after her temporary nursing assistant license had expired, and was thus working as a nursing assistant without a license.
- Respondent states that she was unaware that the temporary license had expired because the owner of the Friendly Home told her that the expiration date of her temporary license had been extended due to the COVID-19 pandemic.
- 4. That the conduct described in paragraph two (2) herein constitutes unprofessional conduct pursuant to R.I. Gen Laws § 23-17.9-1 et seq. and the Rules and Regulations promulgated there under.
- 5. That Respondent admits to the jurisdiction of RIDOH and hereby agrees to remain under the jurisdiction of RIDOH.
- 6. That Respondent has read this Consent Order and understands this Consent Order shall become binding once signed by Respondent and RIDOH.

- 7. That Respondent understands the purpose of this Consent Order is solely to resolve the Complaint.
- 8. That Respondent hereby acknowledges and waives:
 - a. The right to have an administrative hearing on this matter;
 - b. The right to represent oneself or be represented by an attorney of Respondent's own choosing at said hearing;
 - c. The right to present testimony, evidence and witnesses on Respondent's behalf;
 - d. The right to cross-examine witnesses presented by RIDOH;
 - e. The right to further procedural steps except for those specifically contained herein:
 - f. The right to take an appeal from the terms of this Consent Order; and
 - g. Any objection that this Consent Order will be reported to the National Practitioner Data Bank as well as posted on RIDOH's public website.

ACCORDINGLY, AND BASED ON THE FOREGOING

RIDOH and Respondent hereby agree to the following disposition of this Complaint:

- 1. Respondent agrees to a finding that she worked as a nursing assistant after her temporary license had expired.
- 2. Respondent acknowledges that this Consent Order is an agreement between Respondent and RIDOH.
- 3. This Consent Order shall become a permanent part of Respondent's record maintained by RIDOH and a part of a public record of this proceeding.
